Membership Dues for 2024 Suspended

SVOS currently has a balance in our checkbook of \$7000.00. Carol Jurek made a motion to suspend the membership dues for 2024. Rollie Wilson seconded the motion. All present voted in favor of the motion.

Carter and Holmes Presentation in May of 2024

A discussion was held to determine if SVOS would like to have a presentation from Carter and Holmes in May of 2024, and share the expenses with the other Michigan Orchid Societies. The pro's and con's were discussed. No motion was made at this time and the topic will be discussed again at a future meeting.

First Annual SVOS In-House Orchid Show

Many beautiful orchids were judged at the First Annual SVOS In-House Orchid Show. Our Head Judge, Rollie Wilson divided the plants into 6 major classifications: Cattleya, Paphiopedilums, Oncidiums, Phragmipediums, Dendrobiums and Other. Rollie gave an overview on how orchids are judged at an orchid show.

Each member judged the orchids and voted on their first and second place choice in each classification. The results were tallied and winners were declared.

Several members left their plants with Rollie and they were used in the SVOS display at the Ann Arbor Orchid Festival that took place the following week.
